ITS COVERAGE HAS REACHED AN ESTIMATED AUDIENCE OF MORE THAN 46 MILLION. WCIJ IS A NATIONAL MODEL FOR NONPROFIT ETHICS, FINANCIAL TRANSPARENCY, COLLABORATION, AND PRODUCTION OF HIGH-IMPACT STATE AND LOCAL INVESTIGATIVE JOURNALISM THAT TRAINS CURRENT AND FUTURE GENERATIONS OF INVESTIGATIVE JOURNALISTS.
